## 6. Old Business

a. Devan gave his executive director's report. He gave an update on the LOT Sales and Media Mission to Amsterdam, Paris, and London. During that trip, he was able to meet with over 150 tour operators, journalists/travel writers, and travel agents who specialize in European travel to the Deep South. He also recently hosted a Fam Tour for 4 international travel writers to show them everything West Feliciana Parish has to offer for visitors. He reviewed the Feliciana Backroads Trail with the board, and they gave him feedback on what to edit to make the trail more comprehensive. He and the board discussed the Live Like a Local campaign that will launch in August. The campaign will encourage locals and visitors to patron local businesses and attractions during a 4 week period in August and September. He spoke with Kenny Havard to get an update on the progress to get short-term rentals in the parish to register with the School Board to ensure that they are remitting occupancy taxes correctly. Havard said he is having the parish lawyers review the policy. John requested that there be a draft ordinance for the board to review by the May board meeting.
