- 3. A motion to approve the agenda items for consideration and action was made by John and seconded by Jim. All were in favor.
- 4. Public Comment-No public was present to comment.

- 6. Old Business
 - a. Devan Corbello gave his executive director's report. He updated the board on key meetings he had over the last month. He gave an update on earned media St. Francisville and West Feliciana Parish were featured in. He also gave an update on the Feliciana Backroads Trail map. Final updates will be given to the designer. He spoke with Kenny Havard to get an update on the Parish's ordinance on Short-Term rentals to ensure they register with the school board prior to receiving their licenses. Devan and the board discussed implementing a Tourism Recovery & Improvement District to raise funds to help with community connectivity projects to allow both locals and visitors better options for parking, biking, and walking around the town and parish. Live Like a Local campaign will launch in August and businesses are signing up to be part of the Passport for participants to use.
